## MINI-GRANT AWARDEES ANNOUNCED

Congratulations to the eight agencies that successfully competed for funds to help improve the environmental health of their communities!

The Tracking Program is pleased to announce the eight awardees of the *Taking Action with Data* funding opportunity!

Each of the eight grantees were awarded up to \$10,500 to work on environmental public health projects in their communities. Below is a list of the awardees and the topic they will be working on:

- Burnett County Department of Health and Human Services: Carbon monoxide
- Eau Claire City-County Health Department: Nitrates in private wells
- Florence County Health Department: Arsenic in private wells
- Grant County Health Department: Heat stress
- Iron County Health Department: Nitrates and bacteria in private wells
- Lincoln County Health Department: Heat stress
- Rock County Health Department: Nitrates in drinking water
- South Central Environmental Health Consortium: Nitrates in drinking water

### Active Alerts for a Public Health Emergency: The Case of Carbon Monoxide

Late in the evening of December 13, 2014, a teenager passed out after finishing an indoor hockey game in southern Wisconsin. Other players and spectators reported headaches, nausea, vomiting, and dizziness. Local emergency response staff were contacted and conducted an air quality test that revealed dangerous levels of carbon monoxide (CO).

Tracking staff worked with the Wisconsin Poison Center to create an alert system for these types of mass poisoning events. <u>Read</u> <u>more...</u>

# PREVENTING ICE ARENA AIR QUALITY HAZARDS

The Tracking Program teamed up with others in the Bureau of Environmental and Occupational Health to put together resources to help prevent these poisonings from happening.
