Cuaj Hli Ntuj txhais tau tias yog rov qab mus kawm ntawv rau peb ntau leej ntau tus—cov hnab ris ntawv, cov phau ntawv sau tshiab, lub siab npaj kub lug xav rov mus kawm ib yam tshiab. Peb yuav coj tag nrho cov kev pib tshiab uas txaus siab heev no rau electronic visit verification (kev txheeb npe hauv tshuab hluav taws xob thaum sib ntsib) (EVV) thaum lub Cuaj Hli Ntuj nrog rau txoj kev qhib tsab ntawv xov xwm no. Nyob rau sab hauv, koj yuav pom cov tswv yim thiab nom txwv nrog rau cov lus qhia kom nco txog tias yuav muaj dab tsi tshwm sim tom ntej.

Npaj...Txhij...Mus!

Xav paub tias koj yuav tsum muaj dab tsi rau txoj kev pib qhov EVV kom yog? Hliav koj cov cwj mem qhuav thiab teev ncauj lus tseg: nram no yog cov kev txiav txim uas koj yuav tau txheeb ua tiav ua ntej Kaum Ib Hlis Ntuj Hnub tim 2, 2020.

Cov chaw muab kev pab yuav tau hnub lawv cov chaw them nyiaj (cov HMO, cov koom haum tswj kev tu xyuas):

- Lub chaw them nyiaj puas yuam kom cov neeg ua hauj lwm nyob hauv tib lub tsev siv EVV? Yog tsis yuam, kuv yuav tsum paub ua li cas thiaj tsis duav txog kuv cov neeg ua hauj lwm nyob hauv tib lub tsev?
- Lub chaw them nyiaj yuav tsum muaj cov ntaub ntawv dab tsi thiaj kho tau cov ntaub ntawv teev txog kev sib ntsib hauv EVV?

Cov koom haum muab kev pab yuav tau txiav txim rau lawv tus kheej:

- Koj puas yuav siv Wisconsin Department of Health Services (Tuam Tsev Tswj Xyuas Cov Kev Kho Kab Mob Kev Nkeeg) (DHS)-qhov txheeb txheem Sandata los sis lwm lub chaw muab EVV?
- Yog tias koj lub chaw them nyiaj tsis yuam cov neg ua hauj lwm nyob hauv tib lub tsev kom siv EVV, koj lub koom haum puas yuav kom lawv siv?
- Koj puas xav kom koj cov neeg ua hauj lwm teev tseg cov tes dej num (kev da dej, kev tig cev, thiab tej yam li ntawd) rau hauv EVV?
- Koj puas xav kom cov neeg ua hauj lwm hais kom cov neeg tau kev pab lees paub cov kev sib ntsib rau hauv EVV?
- Leej twg yuav tsum yog tus hu tuaj qhia cov zauv ntawm kev txheeb npe hauv lub tshuab nruab ruaj thaum sib ntsib—cov neeg ua hauj lwm los sis neeg khiav dej num hauv chaw ua hauj lwm? Thaum twg lawv yuav tsum hu tuaj kom txhij?

Cov Ncauj Lus Tshiab thaum lub Xya Hli Ntuj 2020 (2020-31), tis muaj npe hu ua [“Implementation of Electronic Visit Verification for Personal Care and Supportive Home Care Services \(Txoj Kev Siv Electronic Visit Verification rau Cov Kev Tu Xyuas Neeg thiab Kev Pab Txhawb Hauv Tsev\),”](#) yuav teev qhia txog DHS txoj cai rau EVV, nrog rau kev tshab xyuas qhov txheej txheem thiab vim li cas thiaj yuav tau siv, cov ncauj lus yuav nthos tau yog dab tsi thaum lub caij sib ntsib, thiab cov ntsiab lus txhais uas nquag siv hauv EVV. Cov ncauj lus tshiab yuav tsi pab rau cov chaw muab kev pab tiam sis yeej muaj rau txhua tus uas xav nyeem lawv.

Cov Ncauj Lus Tshiab thaum lub Xya Hli Ntuj 2020, tis npe muaj [“Electronic Visit Verification Training for Personal Care Services and Supportive Home Care Services \(Kev Qhia Siv Electronic Visit Verification rau Cov Kev Tu Xyuas Neeg thiab Kev Pab Txhawb Hauv Tsev\),”](#) yuav muaj cov ncauj lus txog leej twg yuav tsum tau muaj kev kawm siv twg. Cov Ncauj Lus Tshiab no yuav qhia cov ntsiab lus txog DHS thiab Sandata cov kev qhia siv. Nws puav leej nthuav qhia cov caij nyoog sij hawm rau thaum twg yuav tsum tau kawm siv. Vim yog Wisconsin siv qhov qauv qhia rau tus neeg qhia siv EVV, nws tseem ceeb uas tus neeg ua hauj lwm ntawm ib lub koom haum twg yuav tsum kawm siv txhij txhua thaum ntxov kom lawv qhia tau rau cov tswv cuab hauv lawv pab neeg kom txawj siv.

Q: Kuv yuav tsum tau ua dab tsi tam sim no thiaj npaj txhij rau Hnub 1 ntawm EVV?

A: Tswj xyuas kom koj lub koom haum thiab koj cov neeg ua hauj lwm rau npe kom tau cov zauv ID tshwj xeeb. Yog tias koj rau muaj npe tau Medicaid, koj lub koom haum yuav siv Medicaid tus zauv ID, tiam sis koj yeej tseem yuav tsum tau ib tug zauv ID rau koj ib tug neeg ua hauj lwm twg thiab.

Yog tias koj lub koom haum tsis rau muaj npe tau Medicaid, koj yuav tau lis kom tiav [Provider Agency Identification Process \(Kev Txheeb Cov Koom haum Muab Kev Pab\)](#) kom tau tus zauv ID rau lub koom haum muab kev pab (saib daim [viv dis aus qhia ua](#)), thiab koj yuav tau muab kom tau cov zauv ID rau tag nrho koj cov neeg ua hauj lwm thiab.

Qhov txheej txheem lis neeg ua hauj lwm tus zauv ID yuav qhib ua hauj lwm pib txhij thaum Cuaj Hli Ntuj Hnub tim 15. Txhua lub koom haum yuav tsum tau [txheeb kom paub thiab qhia txog lawv cov neeg ua hauj lwm](#) ua ntej lawv yuav pib siv tau qhov txheej txheem EVV. [Saib daim viv dis aus qhia ua](#).

Q: Tag nrho cov neeg ua hauj lwm puas yuav tsum tau muaj cov zauv ID?

A: Tag nrho cov neeg ua hauj lwm uas muab kev tu xyuas neeg (cov zauv cim txheej txheem T1019 thiab T1020), thiab tag nrho cov neeg ua hauj lwm uas muab qee cov kev tu xyuas hav tsev (cov zauv cim txheej txheem S5125 thiab S5126) yuav tsum tau muaj cov zauv ID cim neeg ua hauj lwm txawm lawv yuav siv EVV los sis tsis siv.

Q: OK, kuv muaj cov zauv ID rau kuv lub koom haum thiab tag nrho kuv cov neeg ua hauj lwm. Yuav muaj dab tsi tom ntej?

A: Koj puas tau muaj kev kawm siv? Tsuas muaj cov kev kawm siv tim ntsej tim muag mus txog lub Kaum Hli Ntuj Hnub tim 9, 2020, yog li ntawd txheeb nrog [DHS nplooj teev qhia Kev Kawm Siv EVV](#) thiab tswj xyuas kom koj rau muaj npe rau tag nrho cov kev kawm siv uas koj yuav tsum tau muaj! Yuav muaj kev kawm raws siab nyiam txij no mus.
