Opioid and Methamphetamine Treatment Centers: 2019 Report to the Legislature

This report covers the calendar year 2018 activities of the regional opioid and methamphetamine treatment programs created under Wis. Stat. § 51.422.

A total of 876 individuals were served in 2018.

Services offered include:

- Assessment for treatment
- Abstinence-based treatment
- Medication-assisted treatment (MAT), utilizing buprenorphine and naltrexone
- Licensed, 24-hour residential care
- Outpatient counseling
- Handoffs to county-authorized or private continuing care

Medication-assisted treatment utilizing methadone was not provided.

Calendar year 2018 marked the fourth year of operation for the opioid treatment programs created under 2013 Wisconsin Act 195 and the first full year that these programs provided methamphetamine treatment services under 2017 Wisconsin Act 27. The centers are:

- HSHS St. Vincent's Hospital Libertas of Marinette (d.b.a. Northeast Wisconsin Opioid Treatment Services)
- Family Health Center of Marshfield, Inc. (d.b.a. HOPE Consortium)
- NorthLakes Community Clinic

Additionally, 2018 marked the first year of operation for two new opioid and methamphetamine treatment centers created under 2017 Wisconsin Act 27. Grants for these centers were awarded to Family Health Center of Marshfield, Inc., and NorthLakes Community Clinic following a competitive application process. Family Health Center (FHC) of Marshfield, Inc., established the FHC-Ladysmith Alcohol and Drug Recovery Center to serve Barron, Polk, and Rusk counties. NorthLakes Community Clinic partnered with Lake Superior Community Health Center to establish a recovery program to serve the city of Superior and Douglas County.


In 2018, total grant funding in the amount of \$2,262,667 was available for the period January 1 through December 31, 2018. The programs created under 2013 Wisconsin Act 195 each received \$672,000. The Family Health Center of Marshfield, Inc., and NorthLakes Community Clinic received \$333,333 and \$333,334, respectively, under 2017 Wisconsin Act 27.

This report provides summaries of key measures for each program related to the four goals of this initiative.

- Goal 1: To provide regional approved and effective stabilization and residential detoxification services and treatment and support services for individuals addicted to opioids or methamphetamines in rural, high-need areas of Wisconsin. The measurement for this goal is the number of people served.
- Goal 2: To increase retention in opioid and methamphetamine treatment services, improve quality of life, and reduce relapse or return to using illicit drugs. Tools used to measure overall life satisfaction are used as a measurement of this goal.

- **Goal 3:** To reduce the number of deaths associated with opioid use in the areas served by the programs. The measurement for this goal is the number of discharges from the program related to death by overdose.
- Goal 4: To reach out to untreated opioid-addicted women of childbearing age, offer priority admission to services for pregnant women, and reduce the number of infants who are affected by opioids. The measurement for this goal is the number of pregnant women served.
