Opioid and Methamphetamine Treatment Centers: 2022 Report to the Legislature

Five opioid and methamphetamine treatment centers provide a comprehensive array of services for people in underserved areas of Wisconsin, including medication-assisted treatment; overdose prevention education, with doses of naloxone provided; and linkage to aftercare services to support long-term recovery.

Three opioid and methamphetamine treatment centers were established under 2013 Wisconsin Act 195.

- HSHS St. Vincent's Hospital and Libertas Treatment Center (d.b.a. Northeast Wisconsin Heroin Opioid Prevention Education)
- Family Health Center of Marshfield, Inc. (d.b.a. HOPE Consortium)
- NorthLakes Community Clinic

Two additional opioid and methamphetamine treatment centers were established under 2017 Wisconsin Act 27.

- FHC-Ladysmith Alcohol and Drug Recovery Center
- Lake Superior Community Health Center

A total of 643 people were served by the opioid and methamphetamine treatment centers in calendar year 2021 through in-person and telehealth services.

State funding in the amount of \$2,682,667 was available for the period January 1, 2021 through December 31, 2021. The programs created under 2013 Wisconsin Act 195 each received \$672,000. The Family Health Center of Marshfield, Inc., operators of FHC-Ladysmith Alcohol and Drug Recovery Center, and NorthLakes Community Clinic, which partnered with the Lake Superior Community Health Center, received \$333,333 and \$333,002, respectively, under 2017 Wisconsin Act 27.
